A Lenten Faith Journey

Lent is a time that offers us an opportunity to ponder our human condition and the God who made us and desires to live in relationship with us. It began as a time for new believers to learn about the faith into which they would be baptized at an Easter vigil.

One of the traditional practices of Lent has been giving something up, a kind of self-denial. It is meant to be a spiritual practice, helping us focus on love for God and one another. Jesus said, "Deny yourself, take up your cross and follow me." Giving something up for Lent can help us do that. But I have always felt it needs to be connected with reflection on our faith, as it was in Christianity's early years.

God's love and power are released in our lives as faith develops, as our reliance upon God and a dynamic relationship with God unfolds. Prayer becomes more than ritual and Scripture itself becomes exciting to read because it tells us about a God we know and *feel* loves us. We move beyond dogma to experience of God's love and power. Our faith becomes dynamic and motivating.

The Christian life is not one of trying harder, of depending on our finite abilities: "God helps those who help themselves" (Ben Franklin). Rather it is a life of depending on God's infinite abilities and love. It is life lived in fellowship with God. As Luther put it so well, "The Holy Spirit calls me through the Gospel, enlightens me with his gifts, sanctifies and keeps me in true faith." As one of my professors at seminary said, "We don't choose God, God chooses us. But then, just like those first disciples, he expects us to listen and learn, and grow in faith and love."

For Lent let us make a disciplined effort to grow in our faith through daily devotions, prayer, and loving others. It helps us grow in the grace and knowledge of God: Father, Son and Holy Spirit. Don't make it a chore, but a valued journey into God's country.

I am putting out a daily devotional (available in the Gathering Space) that will go along with my Lenten series on the Apostle's Creed. May we all take this opportunity to grow deeper in our faith, hope, and love. A Forty Day Lenten Journey!

ANNUAL COMBINED BUDGET/ELECTION MEETING-1/26/20

Call to Order: The meeting was called to order by President Joan Pritzl at 10:26 am. A total of 64 members were in attendance. Opening Devotions were provided by Pastor Jim Wilson. A motion was made and carried to approve the minutes as prepared from the January 20, 2019 Annual Budget/Election Meeting.

Pastor's Report: Pastor Jim Wilson gave a brief report. In the past year he has been seen an increase in the amount of involvement and commitment. He encourages members to use their individual gifts to share in opportunities to serve in worship and in the community.

<u>Council, Board and Committee reports</u>: The directors of the various boards have summarized what has been done during 2019 and these reports are provided in the Annual Report for 2019.

<u>Review of 2019 financial data</u>: Board Director Stephanie Mittnacht reviewed our income and expenses, giving figures both predicted and actual for 2019. These figures are detailed in the 2019 Annual Report booklet.

Proposed Budget for 2020: Motion was requested and made to amend proposed budget [reason: Pastor's housing. This motion affects line items only, not the total but must be amended because the budget has already been printed.]

Motion was made and carried to amend proposed budget to add lines for Pastor Jim's continuing education and professional expense (they are already part of his covenant but inadvertently were not printed). Motion was made and carried to add \$600 to the Pastor's Contract for this purpose. Motion was made and carried to accept the proposed amended budget and open the floor for discussion.

Explanation of proposed 2020 budget by section – Stephanie Mittnacht

Income: 119 People returned pledges this year totaling \$299,802 when the budget was printed, with an actual final total of \$303,000. There is \$114,000 left on the Capital Appeal.

Administrative/Office Expenses: Was left the same as 2019

Benevolence: Total of all Benevolence has been increased from 5% of actual income in 2019 to 7% for 2020.

Board of Church Property: An extra \$5,000 was added for equipment to catch up with things that need to be done that have been put off recently.

Board of Christian Education: Was left the same.

Board of Evangelism: Was raised from \$2,300 in 2019 to \$3,420 to cover expenses for the new web site and the fact that it will now have a maintenance fee.

Board of Lay Ministry: Was left the same.

Board of Fellowship: Was left the same.

Board of Stewardship: Was left the same.

Board of Youth Ministry: Was left the same.

Personnel Committee: Was slightly increased from \$70,356.80 to \$73,267.11

Discussion/questions on proposed 2020 budget: Question was raised regarding funding for continuing education for teachers. Answer: This usually comes out of the Memorial Fund. Staff Expenses were increased just slightly in making adjustments in a few areas. Our Thrivent dollars received will be equally divided between Hands-On Mission and Expanded Ministries. **Approval of 2020 budget:** Motion was made and carried to accept the proposed budget as amended. A voice vote was taken, budget passed.

Elections for Faith Lutheran Church leadership positions for 2020

Pre-printed ballot with nominations as reported by Nominating Committee was distributed to members present. Nominations on the ballot were accepted. Nominations added from the floor were: Cheryl Domrath for Director, Board of Fellowship and Erin Lenzner for the Nominating Committee. Motion was made and carried to close the nominations and for a unanimous vote.

Annual Congregational meeting – temporary Recessed for FLC 2020 Cemetery Committee meeting: FLC Cemetery Committee meeting, report and elections. Bill and Sue Riesterer will take care of the Gjerpen cemetery lawn and Don, Loren and Brian will take care of Our Savior and West.

President's message: President Joan Pritzl reported it had been a good experience and that there were many good things that had been accomplished with this Council which she feels is a good team. She thanked the congregation for the opportunity to have served them.

Benediction/Closing Prayer: Pastor Jim Wilson led those assembled in the Lord's Prayer. Adjournment. Motion made and carried to adjourn the meeting 11:29 a.m.

Council Discussion and Planning

Stewardship for All Seasons: The next focus will be on communication, such as being clear and specific of what is expected when asking for volunteers. Stephanie will send members information about this. Focus will also concern who to ask and how to go about it when donating, in terms of a will; etc.

Congregational Sustainability Assessment: What is basically meant is to determine if we are a growing or dying congregation- important here because while the number of baptized members has increased slightly, our highest giving members are aging. Specific numbers are being compiled, and Pastor Jim will get us copies so that we can get a better picture and take any needed action.

Core Values Discussion: Just a few changes were recommended at our last meeting; it was discussed whether to make these changes or leave the values as had been written.

Motion made & carried to update the wording concerning three of our listed Core Values: Grace, Love, and the value 'Biblical Learning' changes to simply 'Bible'.

OLD BUSINESS

<u>Website Report</u>: Julie Endries reported that things are moving ahead, and although there is not a specific date, things are getting close to being ready. The site has been released to us and the next step will involve those to be trained for working with it.

<u>AV System Updates:</u> Bill talked to Kelly who said that the company he is dealing with was shut down over Christmas but he will order things to get started as soon as he can. He also met with Quinten and Jason Robley who wrote down exactly what was needed here, and that will be used to get things going. We have now received an estimate to make church essentially WIFI accessible throughout. Members received a copy of this estimate. Having been planned as part of our Stewardship for All Seasons, money for payment will come from the increase seen from that source.

Motion made and carried to move ahead to get the work done with estimate given to us.

NEW BUSINESS

<u>Approval of Interim Covenant with Pastor Jim Wilson</u>: Brief discussion for clarification. Motion was made and carried to approve our Covenant with Pastor Jim Wilson.

<u>Proposed Compensation for Noah Liermann, Bell Choir Director</u>: Bell Choir has been reinstated and seems committed; Noah is doing an excellent job, is working extra to get members back up to speed. It is recommended he get extra compensation for his extra time. Motion made and carried to give extra compensation for the extra practices at \$26.25/time, whether it is for a practice or performance, totaling \$52.50 on those Sundays when there is both- a practice followed by a performance.

Lay Ministry – Communion will be every other week during Lent; Communion to start on Ash Wednesday.

Next Christmas the 5:30 service will be returning to the 5:00 time slot. Motion made and carried to transfer \$400.00 from Undesignated Memorial Funds (1080) to the current Bell Choir Account (1020). This is money to be used for future (every 5-7 yrs.) bell maintenance.

Evangelism – The signage for the Gathering Space is up. The window is up with a Christmas wreath for December. The decoration will change on the window seasonally. February 23^{rd} Chili day—proceeds to LWR. New placemats, printed in-house, are here and ready for use.

<u>Property</u> – The estimated cost for the 2 spare bulbs for the projector is around \$700.

<u>Youth and Family Ministry</u> – Walk through Bethlehem should be connected to a service next year. February Events: Need chaperones, male and female, for Junior Youth Gathering. Sunday, February 16th Valentine's Event for youth at church. Bible Study for Girls and Women on Saturday or Sunday mornings

Adjourn: Having completed all business, a motion was made and the meeting was adjourned with the Lord's Prayer at 8:38 pm.

Time Sensitive Material-Do Not Delay



In many places, March is notoriously windy: "In like a lion ...!" Though I don't like the damp chill that's often part of the transition to spring, I love windy days. Something about the air's movement — a gentle breeze or ferocious gale blowing through trees, against the house, in my hair — breeds excitement in me, anticipation that something new is astir.

How fitting that in conversation with Nicodemus, Jesus said, "The wind blows where it chooses, and you hear the sound of it, but you do not know where it comes from or where it goes. So it is with everyone who is born of the Spirit" (John 3:8, NRSV). Like Nicodemus, we fail to comprehend the Spirit of God. But Jesus reminds us that though we can't see the Spirit, we feel his love, see his actions of justice and hear his sounds. These include kind words, bold preaching, weeping for another, shared laughter and songs of praise. —Heidi Mann
